Introducing the Center for Dispute Settlement

Mission: To use and promote peaceful dispute resolution processes throughout our communities through mediation, arbitration, conciliation, facilitation, negotiation, and training.

Services: Mediation is an alternative to the court process and is private, confidential, and voluntary.

Mediation services can be provided upon appointment. Mediation offers persons in conflict the opportunity to work with a mediator to discuss issues, explore solutions, and develop their own agreement outlining what will be done to resolve the dispute. Mediators are not counselors and do not give legal advice. Our mediators have completed a 35-hour state-mandated training program and apprenticeship prior to mediating cases. Programs may have a minimal fee or are offered on a sliding scale.

Programs offered include:

Custody and Visitation Mediation - In cooperation with Family Court, persons who have child/children in common can mediate the terms of their custody and visitation agreement. If an agreement is reached, the parties do not have to go to court. An agreement reached in mediation becomes the court order following review by a family Court Judge.

Divorce Mediation/Arbitration - Divorcing couples can mediate all the terms of their divorce including custody and visitation issues. Couples who are divorcing or are already divorced can resolve issues pertaining to division of property by participating in our Divorce Arbitration Program.

Special Education Program - Parents of students with disabilities and school district personnel can mediate with a specially trained mediator to work out differences in a collaborative way. Mediation may result in written agreements and the agreement is enforceable in any State court of competent jurisdiction or in a district court of the United States.

Small Claims Program - Parties meet to mediate and resolve their legal matter and come up with their own solution to the issue at hand.

Volunteer Opportunities: We welcome new volunteer mediators. Volunteers are required to complete a 35-hour state-mandated training and apprenticeship program.



Friendly professionals will be on hand to provide Narcan and CPR instructions, as well as assistance completing paperwork for the Department of Social Services.

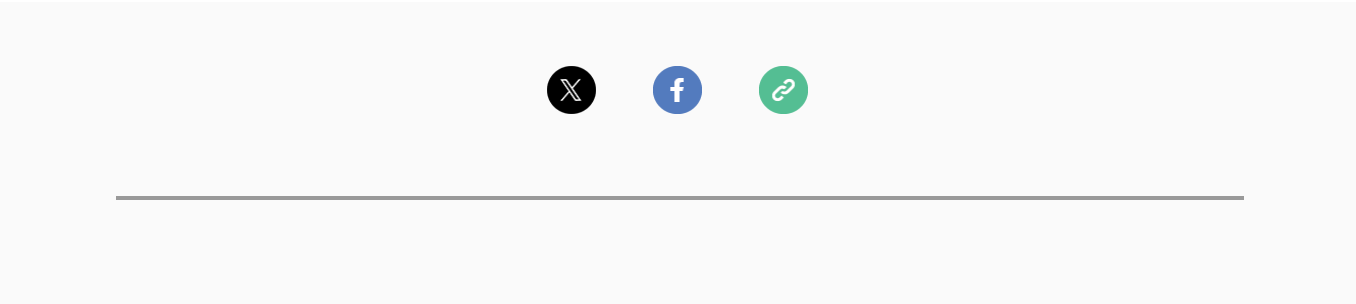
